

## SEC Rule 606 Report Order Routing Information For the quarter ending September 30, 2019

Commerce Brokerage Services, Inc. has prepared this report, which reflects the Order Routing Statistics for transactions executed through our clearing firm, National Financial Services, LLC ("NFS"). The Securities and Exchange Commission requires that brokerage firms make publicly available quarterly reports on their order routing practices. The report provides information on the routing of "non-directed orders" - any order that the customer has not specifically instructed to be routed to a particular venue for execution. For these non-directed orders, Commerce Brokerage Services, Inc. utilizes the trade execution systems provided by NFS. NFS uses a variety of marketplaces to execute orders. All orders are monitored for price improvement and execution quality.

The report is divided into four sections: securities listed on the New York Stock Exchange; securities listed on the Nasdaq Stock Market; securities listed on NYSE American or Regional Exchanges, and Exchange Listed Options.

For each section, this report identifies the venues most often used to execute orders, and sets forth the percentage of various types of orders routed to these venues, and discusses the material aspects of Commerce Brokerage's relationship with the venues, if any. It is suggested that this information be viewed along with Rule 11Ac1-5 and as applicable Rule 11Ac1-6 information, for the specific venues identified, by viewing their publicly available information web sites.
